NTEGRATOR STRENGTHENS ORDER BOOK WITH S\$20.9 MILLION WORTH OF NEW CONTRACTS

- **Total of three contracts from leading regional telecommunications players, Viettel Corporation and SingTel**
- **Fourth contract secured from local statutory board CAAS**
- **Total outstanding order book increases to S\$53 million**

Singapore, April 24, 2009 – Ntegrator International Ltd. (“Ntegrator” or “the Group”), a leading regional communications network specialist and systems integrator, today announced that it has won four new contracts worth a total of S\$20.9 million, boosting the Group’s current outstanding order book to S\$53 million.

Out of the four contracts, three were secured from Ntegrator’s long-time customers, Vietnam’s largest telco operator, Viettel Corporation and Singapore’s SingTel. Both have been providing Ntegrator with repeat business since the Group commenced operations in 2002.

The fourth contract was clinched from the Civil Aviation Authority of Singapore (“CAAS”), the governing authority for the civil aviation industry in Singapore. This is the 2nd contract clinched from CAAS since CAAS awarded its maiden contract to Ntegrator in 2007.

Of the total contracts awarded, the biggest contracts are from Viettel Corporation. Under the terms of the two contracts awarded by Viettel Corporation, Ntegrator will provide infrastructure expansion for Viettel Corporation including IP router and Synchronous Digital Hierarchy (“SDH”) infrastructure in Vietnam. These build on earlier contracts won by Ntegrator with Viettel Coporation.

The Group will be providing the supply of Digital Distribution Frame to SingTel over a two-year duration, and will install a voice communication system under the terms of the CAAS contract.

Commented Mr Jimmy Chang, Managing Director of Ntegrator: “To be awarded successive contracts by the region’s leading players in their respective industries bear testimony to our trusted track record and strong technical expertise in providing customised solutions for network infrastructure and voice communication systems.

“We will continue to focus on our strategic plans for the Group’s growing footprint in the emerging Indochina region, with emphasis on Vietnam, as opportunities continue to open up for us.”

All four contracts are expected to have a positive impact on the earnings of the Group for FY2009.
